

COURT ORDER FOR ASSISTANCE TO THE BLOODLINES¹

MERCY COURT OF HEAVEN

Surnames in Bloodlines:

Plaintiffs (hereafter referred to as Bloodlines,

vs.

The Principality of Baal, et al.;

The Principality of Queen of Heaven, et al.;

The Principality of Leviathan, et al.;

The fallen sons of God ruling the tribes in the bloodlines;

The Celestial Astrological Kingdoms of Darkness: sun, moon; the Twelve Houses in the heavenly realm, and any other celestial entities known or unknown;

Covenants made on the Trading Floors of Darkness;

The principalities, powers, world rulers, spiritual hosts of wickedness, and any spiritual entities known or unknown;

Nephilim pollution of the bloodlines;

All wisdom, understanding, and knowledge attained by the bloodlines from the Tree of Knowledge of Good and Evil,

Defendants (hereafter referred to as Demonic Entities).

This matter comes before this Court seeking enforcement of its prior decrees of divorce in favor of the Bloodlines.

The Bloodlines seek to employ an ancient order used to assist the subjects of the king in fulfilling the duties of their king. In more recent time, it is “a mandatory injunction” to bring about a change in the possession of real estate—it removes the current occupant and gives possession to the one ruled entitled to it by the Court.” (63 P2d 756,759)

The Order of Assistance is a ruling issued by the Mercy Court to transfer the possession of lands, title or possession to which the Court has previously ruled. It is a means of enforcing its decree. (110 P2d 554,556)

Accordingly, the Court finds:

1. The Bloodlines have sought and obtained from the Court Decrees of Divorce. The Bloodlines were found to be entitled to sole right, claim, and interest, in and to all gifts, possessions, and inheritance from the Bloodlines' Father. The Demonic Entities were forever banned from the title, control or use of such gifts, possessions or inheritance (Psalm 24:1, Psalm 115:16).
2. The Bloodlines have committed and do continue to affirm their commitment, to avoid any contact or participation with the Demonic Entities listed above or with any entity in their vast network. The Bloodlines commit to being trustworthy in the use of the gifts, possessions, and inheritance to which they are legally entitled.
3. The Bloodlines are entitled to the blessings of Abraham, (Galatians 3:13-14) and are entrusted with those blessings to be a blessing in the earth (Genesis 12:2-3). This Court holds that the blessings of the Bloodlines' Father are to make the Bloodlines truly rich, and He intends no sorrow or toiling to be added to it (Proverbs 10:22). Additionally, this Court finds the wealth accumulated by those following the Demonic Entities' practices lawfully belong to the Bloodlines remaining in right standing with this Court (Proverbs 13:22, 1 John 3:8).

In addition to this Court's Decrees of Divorce entered on *(date)* _____ against the Demonic Entities in favor of the Bloodlines, this Court finds that previous proclamations of this Court support the issuance of this Order of Assistance, including the following:

- The thief must repay sevenfold, and must give all the substance of his house (Proverbs 6:30-31). He must restore seven times what he has taken.
- The wicked man, though he piles up silver and has plentiful garments, the just will wear them and the innocent will divide the silver (See Job 27:13-17).
- The Bloodlines' inheritance is from the Father who purposed that only His House be filled with splendor because the silver is His, and the gold is His. It is to His House that He grants peace and prosperity (See Haggai 2:7-9).
- It is the will of the Father that the Bloodlines alone receive the "treasures of darkness and the hidden wealth of secret places" (Isaiah 45:2-3).

While the Demonic Entities claim as their own vast possessions, this Court has ruled, and does here again rule that "He who by charging excessive interest and who by unjust efforts gets gain and increases his material possessions gathers it for those who are kind and generous to the poor," the Bloodlines here (Proverbs 28:8). While the Demonic Entities have gathered it, this Court rules, "they must give it" to the Bloodlines who are "good in God's sight" (Ecclesiastes 2:26).

The Highest Court having fully considered the Bloodlines' plea for an Order of Assistance to enforce its prior rulings and proclamations and finding this request timely made, does this day issue this Order of Assistance on behalf of the Bloodlines:

- Giving the Bloodlines this day power to gain wealth to confirm this Court's covenant with their fathers (Deuteronomy 8:18).

- Ordering that all those empowered by this Court to enforce its rulings and proclamations immediately.
- Granting full assistance in the transfer of all wealth, possessions, properties, and gifts belonging to the Bloodlines.
- Employing the power and might of this Highest Court to perform this Word.
- Calling into obedience all enforcement authorities (angel armies) to continue in this transfer until it is fully completed and the Bloodlines are in unchallenged possession (Psalm 103:19-21).

This Order extends to all extensions and manifestations of the Kingdom of Darkness, however, named or designated, known or hidden, and however related to the Prince of Demons (Matthew 12:24).

It is the unlimited authorization of this Order to bind every strongman operating against the Bloodlines:

- To take possession of every house of captivity over which the Kingdom of Darkness has ruled.
- To authorize the enforcement authorities to remove all property belonging to the Bloodlines in the possession of the Kingdom of Darkness,
- To plunder the strongman's house (Matthew 12:29).

Therefore on *(date)* _____, let the Order be issued and from this ruling there shall be no appeal.
