The demonic wisdom, understanding, and knowledge attained by the bloodlines from the Tree of Knowledge of Good and Evil,

Defendants (hereafter referred to as Demonic Entities)

DECREES OF DIVORCE

This matter comes on *(date)* _____ for hearing before the Supreme Judge of the Mercy Court in the Kingdom of God on the petition of the above listed Bloodlines seeking Decrees of Divorce from the Demonic Entities in this divorce.

The Court finds the Bloodlines' assertions are fully established:

- These covenants of marriage were entered into by the Bloodlines based on lies and deceit by the Demonic Entities.
- The Bloodlines relied on the false promises and enticements for gain presented by the Demonic Entities which the Demonic Entities had neither the intention nor ability to deliver.
- The Bloodlines renounce any and all right, claim or interest in any possession jointly acquired with the Demonic Entities during these covenants of marriage.
- The Bloodlines relinquish any and all joint claims with the Demonic Entities, and request this court to sever all relationships with the Demonic Entities of any nature, however, and whenever such occurred.
- The Bloodlines are entitled to have the sole right, claim, and interest, in and to all the gifts, possessions, and inheritance from the Bloodlines' Father.
- The Demonic Entities are now and forever banned from the title, control, or use of any such gifts, possessions or inheritance.
- The Demonic Entities are purged from the body, soul, and spirit of the Bloodlines, which had been contaminated by these covenants of marriage. All corruption of the DNA from these covenants of marriage are removed—replaced with the perfection of the Father's original plan. All resulting captivity, oppression, curse, depression, mental illness, disease, and birth defects are reversed to the original plan of creation. The Bloodlines are now able to be children of Father God.
- The Bloodlines seek enforcement by this Court of the Bloodlines' desire to be known by no other name than that given by the Bloodlines' Father.
- The Bloodlines also seek an everlasting restraining order against the Demonic Entities to keep the Defendant away from all persons or property belonging to the Bloodlines.

THE JUDGMENT

WHEREFORE, this Court being fully advised in the evidence does find for the Bloodlines and against the Demonic Entities in all matters material to the Bloodlines' Petitions of Divorce, and does by these decrees grant the Bloodlines a Divorce from every entity listed and grants all requests set forth above.
